Centennial Convention Recap

The centennial year of the Rocky Mountain Coal Mining Institute was celebrated in style at the 100th Anniversary conference held June 30 – July 3 in Vail, Colorado. We thank our many sponsors, speakers and program organizers who helped us look "back to the future" of RMCMI.

The centennial celebration was kicked off with a gala on Sunday evening. Life member and Past President Charlie Margoff, received a standing ovation for his remarks confirming that our national heritage of freedom will overcome the challenges faced by the coal industry. The legacy of the past 100 years was captured in a commemorative book of historic photographs and RMCMI memorabilia. Due to the generosity of Murray Energy Corporation, each conference attendee received this publication free of charge. The evening was capped off by a lively panel discussion between young professionals and RMCMI senior pastpresidents, moderated by PresidentElect **Brad Lewis**. The debate showed that the young professionals are clearly up to the task of taking the coal industry into the future. We thank Komatsu for sponsoring the banquet and PacifiCorp, Savage Services Corporation and Snell & Wilmer for the opening reception.

The program on July 2nd and 3rd focused on the next 100 years of RMCMI. Keynote speaker Steve Leer, Chairman of Arch Coal, addressed new markets and the "Global Outlook for Coal." Chris Curfman presented Caterpillar's perspective on "100 Years: Looking Back, Looking Forward" technological including changes anticipating the robotic and remote control mining equipment of the near Chris Frangione with the future. X-Prize Foundation announced that a \$10 million prize is being developed as an incentive to encourage carbon capture and reuse technology. utility forum addressed the future of coal as the base load supporting electrical energy generation. panel, moderated by Bob Bartosh with Dakota Coal, included perspectives of Rich Walje, President of Rocky Mountain Power, Shawn Taylor, Executive Director of the Wyoming Rural Electric Association, Robert King, President and CEO of Westmoreland Coal. The permitting and development of the Longview coal terminal, proposed to export western coal to new markets was addressed by RMCMI past President Ken Miller

and Kristin Garner with Millennium. Joel Dingman with Basin Electric Power, discussed leading edge power plant technologies incorporated into the new Dry Fork Station which is coal-fired, generates 385 MW and exceeds new air quality requirements for SO2 and mercury.

On the policy front, Bruce Watzman, Senior Vice President of the National Mining Association, highlighted new trends in federal safety regulations. He challenged the industry to meet the goal of zero fatalities, 50% reduction of accidents within 5 years, through implementation of the CORE safety framework. Barry Smitherman, Chairman of the Texas Railroad Commission updated us on the Texas response to EPA regulations affecting coal and coal-fired utilities. Perry Pendley, Mountain States Legal Foundation, and Karen Budd-Falen discussed litigation strategies in response to the anti-coal campaign.

On a parallel track to these presentations, RMCMI sponsored a 4-day mine rescue event which included 130 participants. Staging the team mine safety scenarios presented a special challenge in the conference setting at Vail, Colorado. Organizers David and Cheryl Evans, with sponsor North American Coal, did a tremendous job and received great press from the Antler's Hotel which produced a blog and photographs of the teams involved in mock rescues.


The evening finished with entertainment from the Danny Showers Band. It was quite a memorable evening to celebrate our past 100 years and begin the next 100 years!
















Auction to benefit Scholarship Fund a Huge Success!

Minutes of the Annual Membership Meeting, July 3, 2012

President Denise Dragoo called the meeting to order at the closing luncheon of the Rocky Mountain Coal Mining Institute's 100th Anniversary Conference and Annual Meeting held at the Vail Marriott Resort, Vail, Colorado. The purpose of the annual meeting is to inform members of the status and activities of the Institute during the year. The minutes of the previous meeting were approved as published in the 2011 Post-Conference newsletter. Denise reviewed the accomplishments of the committees this past year:

72 members were added to date this year.

David and Cheryl Evans continue to do an outstanding job as co-chairs of the Mine Rescue program. Twelve teams, including three new Newmont teams, participated this year. The program included a new class this year, "Guts and Gore", that involved respiration techniques on pig hearts and lungs. This class was well received and requested again for next year.

Bruce Lindsay, Golf Chair, continues to make the RMCMI golf tournament a huge success. We had 104 golfers participate this year. \$1,560 in mulligans was sold at the tournament to benefit the scholarship fund.

Curt Moseley took over mid-year as Patron Chair, and has done a great job in bringing the program up to date for the year. He issued a challenge to match funds, which created additional patron contributions during the conference. The silent/live auctions raised approximately \$12,000, and with the additional contributions during the conference we added approximately \$20,000 to the scholarship fund. As of the 100th Anniversary, over \$1 million dollars in contributions have gone into the program through the years.
